This form lets you apply for a warrant that will enable a bailiff to give possession of residential premises to the person named in a Tenancy Tribunal order. Use this form if the following applies: you have a Tenancy Tribunal order saying that possession of residential premises is to be returned to you by a specified date but Eviction Notice (Notice of Termination of Tenancy for ...

A tenant cannot object to a 14 day eviction notice given because of unpaid rent. The only thing a tenant can do is pay all of the rent that is owed, and the rent that is due by the termination date in the notice.

Once the landlord obtains an Eviction Order from the LTB, a copy must be taken to the Sheriff's office, and a document known as a Writ of Possession requested. The Writ of Possession gives the Sheriff the legal power to enforce an eviction.

For example, if the order says that the tenant must move out on or before April 15, you can file the eviction order with the sheriff on April 16. If April 16 is a weekend, you can file for eviction on the first business day after that day. Eviction order stands for vulnerable Pointe-Saint-Charles ...

In order to officially start the eviction process, you need to deliver an eviction notice (also known as a notice to quit) to your tenant. Deliver the notice by posting it to the tenant's door while also sending it by Certified Mail with Return

Receipt Requested via USPS. As the landlord, you need to send the correct type of eviction notice (30-day eviction notice is the most common)
